LICENCE FEES (Information concerning licence fees is available at www.ficora.fi.)

The licence fees shall be paid before the radio equipment can be taken into use.

GSM and UMTS mobile stations as well as LA (CB), PR 27 and analog and digital PMR 446 telephones are exempted from licensing, provided that they fulfil the requirements of relevant equipment standards and specifications. The use of all other kinds of radio transmitters is subject to a licence issued by the Finnish Communications Regulatory Authority (Ficora). The Ficora shall be notified of the frequencies in the equipment in question, upon which the Ficora will decide on assigning the customer a suitable frequency and will issue a licence for the radio transmitter.

The radio transmitters and the licences will be inspected during the event. Radio transmitters in aircraft will be inspected as well.

The use of radio transmitters will be monitored throughout the event. Unlicensed use or use outside the terms of the licence of a radio transmitter, may in case of serious interference lead to prohibition of the use of the radio transmitter.
